HIGHLIGHTS 2021 – 2022



Syngenta India Limited (CSR) Year 3

The I-SAFE implementation programme is an intense training programme to farmers on "Health & Safety" precautions, to bring about awareness on the potential harm from exposure to pesticides implemented by IRFT and funded by Syngenta in Khargone and Dhar District of Madhya Pradesh. The first year IRFT had covered 11021 Farmers and 2065 Spray-men family counselling in both the districts, and the second year we have covered 10090 Farmers and 1117 Spray-men family counselling in both the districts and this year (2021 – 2022) IRFT has covered 10091 Farmers and 1018 Spray-men family counselling in both the districts.

IRFT implemented the I-SAFE programme with the support from the Agriculture Department, KVK's, ATMA and Syngenta Field Staff. IRFT briefed them about the Initiative before implementation. In collaboration with them and under their guidance, IRFT implemented the I-SAFE programme in Dhar and Khargone District for 3 years successfully.

Farmer Training:

IRFT met the Agricultural Department Officials to suggest Blocks and Villages to implement the programme. IRFT conducted Farmer Health and Safety awareness programmes in different Villages suggested by Agri Department. The training sessions were attended by farmer communities in which IRFT covered Health, Safety, Hygiene, Farm Safety, COVID-19 Precautions, Do's and Don'ts while Handling Pesticides followed by PPE Kit Demonstration.
